**CMP 2007 Resource Limited Partnership  
completes rollover into Dynamic Managed Portfolios Ltd.**

**Toronto, May 26, 2009** – CMP 2007 Resource Limited Partnership (“CMP 2007” or the “Partnership”) is pleased to announce that it has completed the transfer of its assets into Dynamic Managed Portfolios Ltd. (“DMP Ltd.”) in exchange for shares of DMP Resource Class. The Partnership and DMP Resource Class are managed by Goodman & Company, Investment Counsel Ltd. (“Goodman & Company”).

On the date of transfer, May 22, 2009, the net asset values for CMP 2007 and DMP Resource Class were \$177.86 per unit and \$14.08 per share, respectively. Upon the dissolution of the Partnership, on or about June 19, 2009, shares of DMP Resource Class will be distributed to the limited partners. In the interim, investors in the Partnership can determine a value for their holdings by multiplying the number of units they held in the Partnership by 12.6341 shares of DMP Resource Class. The pro-forma net asset value per unit of CMP 2007 will continue to be available on the CMP™ website ([www.cmpfunds.ca](http://www.cmpfunds.ca)) until the dissolution of the Partnership.

DMP Ltd. is an open-ended mutual fund corporation that currently offers seven classes of mutual fund shares that are managed by Goodman & Company. Each class of shares constitutes a separate mutual fund (each a “DMP Fund”), DMP Resource Class being one of the DMP Funds. The multiple class structure allows investors to switch between different classes on a tax-deferred basis and reposition their investment portfolio to meet their individual investment requirements.

CMP is a leader in flow-through share financings, with a history dating back to when flow-through shares were first introduced by the federal government. Since its creation in 1984, CMP has successfully raised and invested over \$2.4 billion in companies active in exploration and development efforts across Canada. When combined with Canada Dominion, the two partnerships form the largest flow-through investing platform in Canada, raising a combined total of more than \$3.5 billion in assets throughout their history. Goodman & Company, manager of the Partnership, the flow-through limited partnerships of CMP and Canada Dominion and the seven DMP Funds, also manages the mutual funds, hedge funds and closed-end investment trusts of Dynamic Funds™, the portfolio solutions of the Marquis Investment Program, and the high-net worth investment counsel of Goodman Private Wealth Management.
